### FREQUENTLY ASKED QUESTIONS (FAQs)

- ❖ When are membership fees due?
  - Every Year (Annually) – July 1<sup>st</sup>
- ❖ How do I find out how much annual membership fees cost?
  - ANA will send out annual renewal letters

- ❖ Where do I send the annual membership form and fees?
  - You may mail both your completed form and fees to the ANA address found in your renewal letter.
  - You may scan and email your form to [info@naprapath.org](mailto:info@naprapath.org)
    - Please be sure to write your paypal confirmation number under your signature when sending completed forms electronically.
  - You may fax your form to the ANA fax number displayed on the renewal letter.
    - Please be sure to write your paypal confirmation number under your signature when sending completed forms by fax.
- ❖ Do I need to complete this same form if any of my information change?
  - Yes
- ❖ How do I get my information updated on the ANA website?
  - Complete the renewal/update form and submit it to the ANA
- ❖ What is included in my membership?
  - Your membership includes discounted entry to the Semi-Annual Meeting & Annual Convention for the current year.
  - Your membership includes discounted rates for entry / participation in other social events hosted by the ANA for the current year.
  - Your membership includes other promotional and member appreciation items and gifts for the current year.
- ❖ Will I see where my membership contributions are being spent?
  - Yes. Every member in good standing will receive an annual budget describing the allocation of funds for the current year.
- ❖ Is there a monthly payment plan option if I am not able to pay annual membership fees in full before the deadline?
  - Yes. We are implementing a monthly payment plan option to better service our members. Members will have to complete and sign a separate form, ACH debit authorization, to utilize our monthly payment option.
- ❖ Is my membership fees tax deductible?
  - Yes. We are a 501c3 tax-exempt organization from the IRS membership fees will be tax deductible.
